Remarks of the President

The President advised those present that he had asked that the special meeting be held to consider two items. The meeting then proceeded to deal with these.

The Programme in Occupational Therapy

The President reported that he has received further information about funding from the Minister of Education. There is a commitment to provide additional funds this year to start the programme in Occupational Therapy and funding for future years would be provided through M.P.H.E.C. While the details are still not yet definite, he recommended that approval be given to implementing the programme for the academic year 1982/83.

He explained that the problems of financing Occupational Therapy are connected with the general financing of health care programmes, about which there are currently problems and uncertainties, but a new round of discussions to deal with these matters is to be initiated by the Minister of Education.

On motion, the recommendation of the President was approved.

Staff Relations Committee

On behalf of the Committee, the President commented on a number of staff changes, a list of which was circulated to those present. at the meeting. On motion, these were approved.

Other Business

Mr. Rans read a letter that he has sent to the Board of Governors of the University of Moncton concerning disciplinary action taken against certain students who were involved with recent occupation of some areas of the university. In answer to questions, he made
