

- Blackburn, Simon. Fellow of Pembroke College, Oxford; Editor of *Mind*. His publications include studies of probability as well as of realism in both philosophy of science and in ethics.
- Braybrooke, David. Professor of Philosophy and Politics, Dalhousie University. One of his chief concerns is the philosophy of social science.
- Brett, Nathan. Associate Professor of Philosophy, Dalhousie University. His special interests are the study of Hume and the philosophy of law.
- Brown, Bryson. Research Associate in the Department of Philosophy, Dalhousie University, where he is occupied with a project on the logic of social change. Philosophy of science is his speciality.
- Brown, James. Assistant Professor of Philosophy, University of Toronto. He has published a number of studies in the philosophy of contemporary physics.
- Burns, Steven. Associate Professor of Philosophy, Dalhousie University. His interests include the philosophy of Plato and Marxist theory; as an officer of the Canadian Philosophical Association, he has been active in relations with French-speaking philosophers.
- Campbell, Richmond M. Professor of Philosophy, Dalhousie University. Ethical theory, the philosophy of biology, and formal decision theory are his special interests.
- Churchland, Paul. For a number of years Professor of Philosophy, University of Manitoba; now at the University of California, San Diego. Author of books and articles on the impact of the philosophy of science upon the theory of knowledge and the philosophy of mind.
- Clark, Peter. Lecturer in Philosophy (Logic), University of St. Andrews, most concerned with the philosophy of mathematics.
- Davies, Dave. At the time of the 1983 conference, a graduate student in philosophy at the University of Western Ontario, working on a doctoral dissertation about metaphysical realism.
- Egan, Mary Frances. Also, at the time of the 1983 conference, a graduate student in philosophy at the University of Western Ontario, working on a doctoral dissertation on issues raised by cognitive psychology.
- Gooding, David. Lecturer in the School of Humanities and Social Sciences, University of Bath. Active in the history and philosophy of science, he has made a close study of the thought and career of Michael Faraday.

Jennex, Dave. At the time of the 1983 conference, a student at Dalhousie, completing his undergraduate courses. He has since gone on to graduate study in philosophy at the University of Alberta.

Katz, Jonathan. Assistant Professor of Philosophy, Dalhousie University, 1984-85; now at the University of Manitoba. Katz's specialty in the philosophy of science is the study of probabilistic explanations.

MacIntosh, Duncan. At the time of the conference, a graduate student at the University of Toronto. He has since been appointed to a Killam Postdoctoral Fellowship at Dalhousie University, 1985-86, and he will be Assistant Professor of Philosophy there beginning 1986.

Martin, Robert. Associate Professor of Philosophy, Dalhousie University. Martin has written on a number of topics relating to the philosophy of literature; but his main interest is the philosophy of language.

Matheson, Carl. At the time of the conference, a graduate student in philosophy of science, at Syracuse University. He has since taught at the University of Manitoba; and is now Assistant Professor of Philosophy at Iowa State University.

Normore, Calvin. Now Associate Professor of Philosophy, University of Toronto; at the time of the conference, Fellow in Humanities, Columbia University, and previously Assistant Professor of Philosophy at Princeton.

Okruhlik, Kathleen. Assistant Professor of Philosophy at the University of Western Ontario. She has published a number of papers on the history and the philosophy of science in the 17th century.

Pappas, George. Associate Professor of Philosophy at the Ohio State University. He has concentrated in books and articles on the theory of knowledge.

Puccetti, Roland. Professor of Philosophy, Dalhousie University. His publications have dealt with the impact on philosophical issues of recent developments in science, ranging from astronomy to brain physiology.

Seager, William. Assistant Professor of Philosophy at the University of Toronto. He is a specialist in the philosophy of science.

Sellars, Wilfrid. University Professor at the University of Pittsburgh. He has long figured among the most prominent living American philosophers, with many important publications, especially in the theory of knowledge, the philosophy of mind, and the philosophy of science.

**Sobel, Jordan Howard.** Professor of Philosophy at the University of Toronto. His work has been equally concerned with ethical theory and with formal decision theory.

**Tomkow, Terrance.** Associate Professor of Philosophy, Dalhousie University. Tomkow's writing is devoted to the philosophy of logic and the philosophy of language.

**Vinci, Thomas.** Associate Professor of Philosophy, Dalhousie University. He works mainly in the theory of knowledge and in the history of philosophy.

**Wright, Crispin.** Professor of Philosophy (Logic), University of St. Andrews; formerly Fellow of All Souls College, Oxford. Wright's chief publications have been in the philosophy of mathematics.
