#### **NOTES**

**Finances**: The net worth of the Institute is \$65,818.46. For this year, revenue included two grants of \$1000.00 each from the Nova Scotia Department of Tourism and Culture as the grant for 2007-2008 was not received until this budget year. The Institute also received \$631.39 from ACCESS copyright for publication royalties.

Expenditures for donations and prizes were \$2050.00. This included \$100.00 donations to each of 10 regional Science Fairs in Nova Scotia, a \$100.00 donation to the APICS Psychology Conference at Mount Saint Vincent University, and a \$200.00 donation to the Annual Northeastern Biological Graduate Student Conference at Saint Mary's University.

Two writing competition awards were given; \$500.00 for graduate and \$250.00 for undergraduate.

**Membership**: The Institute has 110 active individual members including 7 life members and 2 student members. This year there were 10 new members and 2 new life members. Dues from individual members amounted to \$2,660.00 and from institutional members \$508.47.
