- b. W. Maes pointed out that statistics and identified targets are tools he can use to demonstrate the value of the libraries to University administration for ongoing support.
- 2. New Measures: How are we measuring departmental/unit/individual public service?
 - a. M. Paon Learning Commons
 - i. Zoomerang surveys, observations, daily user feedback.
 - b. I. Colford Collections
 - i. CCC board could become on-line tool, counting hits on webpages vs. collecting information on how users use information or how long
 - c. S. Dwyer Circulation
 - i. Quantitative statistics,
 - ii. Internal assessment from staff members on a team building course without their supervisors. Staff assessed department needs. A report has been written and action items have been developed for change in the department. More courses are planned.
 - d. A. Barrett Kellogg Library
 - i. Survey done before Learning Commons built and after to determine what equipment was needed and how equipment was being used.
 - e. G. MacNairn Computer Science POP
 - i. Provides qualitative feedback
 - ii. Resources can be changed immediately to meet needs of users
 - f. G. Pace combining LIBQUAL and study space survey
 - i. Combining qualitative remarks from LIBQUAL and study space survey
 - ii. Will follow up on requests for designated study spaces, wireless connections, sturdy study tables, etc.
 - g. J. Boxall GIS and Maps
 - i. Staff held mini retreat to look at new ways to collect qualitative information including why people come to them
 - h. F. Nowakowski Literacy Information
 - i. Quantitative data available

- ii. Beginning to look at what departments within the Killam Library and other libraries are doing.
- iii. Will be evaluating progress and effectiveness on students.
- iv. Professional development day on learning outcomes held recently with L. Taylor, Centre for Learning and Teaching
- i. S. Longard Reference
 - i. Currently collect quantitative data. Need qualitative information.
- j. K. Smith Special Collections
 - i. Record internal and external reference enquiries
 - ii. Personal interaction with students in classes provides feedback on teaching effectiveness.
- k. M. Moosberger Special Collections and Archives
 - i. Usage vs. conservation Deterioration of holdings occurring in Archives and general collections due to heavy use. Decisions needed soon on preventative measures for some unique material.
- 1. H. Powell Sexton
 - i. All staff attend yearly retreat to set assess goals set previous year and set new ones.
 - ii. Survey users on several issues, e.g., software, hours.
 - iii. Meet with faculty to discuss goals for teaching classes and conduct follow up assessments.
