## SENETE MEETING

Senate met in regular session in the Board and Senate Room on Friday, 9 October 1981 at 4:00 p.m.

## 81:75. Minutes of the Last Meeting

Upon motion (Tonks/Horrocks) the minutes of the meeting of 14 September 1981 were approved as circulated.

## 81:76. Question Period

Ms. Monk asked if an evaluation committee was being set up for the appointment of a Dean of the Faculty of Health Professions. The President replied that a committee had already been formed to review the progress and future of the Faculty as well as to consider the deanship. The committee has had an initial meeting and notice of the committee's existence will be publicized throughout the university community. The President also pointed out that the committee will act in a manner consistent with the regulations approved by Senate, and contained in the Report of the Senate Committee on University Government dealing with the appointment of Presidents, Vice-Presidents, Deans, and Associate or Assistant Deans.

The President also commented that he will prepare a written response on the matter of the appointment of the Dean of the Faculty of Dentistry which was raised at the last meeting (Minute No. 81:69).

Mr. Sprott asked whether the Senate Library Committee had been struck. The Chairman replied that its membership had been approved (Minute No. 81:64.A.4) but it had not met yet.

JOINT MEETING OFT THE
SENATE COMMITTES

The Academic Planning, Financial Planning, Physical Planning and Steering Committees met at an informal joint meeting in the Board and Senate Room on Monday, 26 October, 1981 at 7:00 p.m.

Present with Mr. A.M. Sinclair in the chair were the following members:

In the absence of Mr. J.A. McNulty, Mr. P.M. Pronych acted as secretary.
Mr. Sinclair opened the meeting by remarking that this meeting was initated by the steering committee partly for the purpose of hearing the financial report prepared by the financial planning committee prior to the presentation of it at the Special meeting of Senate on 2 Novembers 1981 but mainly, to discuss the relationship of the various committees in the new Senate structure. Mr. Sinclair also stated that as the meeting was of an informal nature to discuss the financial planning committee report it had no mandate to vote upon the report. It was hoped that discussions and subsequent recommendations for improvements to the report would occur at the level of each committee and would be brought to the attention of senate at the scheduled special meeting. Minutes of this meeting would be circulated as a matter of information.

## Item 1 Report of the Senate Financial Committee

Mr. Jones, Chairman of the financial planning comm;ttee presented the report as prepared by the FPC. The report (previously distributed) dealt with the serious financial situation at Dalhousie University, the contributing factors for the University's present indebtiness, as well as recommendations by the FPC for the type of short term and long term actions necessary to reduce the large University deficit without severely compromising academic programs. A lengthy discussion consisting of questions and observations followed the presentation of the report. A minority report was also circulated as an addendum to the principle report. Mr. Sinclair summarized the comments from the discussions and requested that the committees meet after the meeting to further discuss the report and decide how to proceed with the report.

Item 2 Role of the academic planning over the next two years:
Mr. Sinclair outlined what he perceived to be the short term and long term objectives and the goals of the steering committee, the academic planning committee and its sub-comm;ttees, the financial planning and physicaL planning committees. Mr. Sinclair observed that the comm;ttees appeared to be working rather loosely and not following a formal structure. The discussion that followed was concerned with the structuring, the inter-relationship, the priorities and roles of each committee
during the period of financial difficulty.

## Item 3 Adjournment

The meetlng adjourned at $9: 15$ p.m. with the request that the committees meet to determine their reaction to the report.
