Upon motion (Kent/Cameron), the awarding of the Guy Henson Gold Medal at this year's, and subsequent convocations of the Faculty of Administrative Studies was approved. This year's recipient is Stewart James Lamont.

82:28. Report by the President on the 1982/83 Budget

President MacKay presented a summary report on the Preliminary 1982/83 Operating Budget, as requested by Senate (Minute No. 82:22). A copy of the report is appended to these minutes.

82:29. Reports and Recommendations -- Committees of Senate

A. Academic Planning Committee

1. Presidential Consultative Committee on the Process of University Planning

The Academic Planning Committee had recommended that Senate accept the invitation to take part in the Presidential Consultative Committee on the Process of Academic Planning (Minute No. APC 82:48). It was agreed that Senate should participate.

2. Resolution re: September Convocation

Upon motion (Jacobson/Haley) the September Convocation to welcome new students and faculty to the University community (Minute Nos. 82:20; APC 82:50) was authorized, without dictating format.

3. Academic Implications of the 1982/83 Budget

The Chairman stated that a preliminary report had been submitted by the Vice-President (Academic and Research) to the Academic Planning Committee which presently had it under consideration.

B. Steering Committee

1. Report on Pension Performance

It was moved and seconded (Roberts/King) to receive the Report on Pension Performance submitted by Mr. Roberts, Senate Representative on the Investments Committee. The motion was carried.

The policy and performance of pension investments was reviewed by Mr. Taylor.

It was reported that the Board of Governors had approved the programmes leading to a Diploma in Meteorology and to a Master of Development Economics. The programmes will now be submitted to the M.P.H.E.C.

The President reminded members of the Spring Convocations, and reported on the Honorary Degree recipients and Convocation Speakers.

82:36. Reports and Recommendations -- Committees of Senate

A. Academic Planning Committee

1. Report of the Academic Planning Committee on the Academic Implications of the 1982/83 Preliminary Budget

The Chairman introduced the report, which had been distributed with the agenda for the meeting, and stated that the Academic Planning Committee had approved recommendations a) and b) on page 3 of the report (Minute No. APC 82:58).

It was moved and seconded (Dresel/Josenhans) that

the two recommendations, as follows, be approved:

a) that it be recommended to the Board that the acquisitions budget of the library system be increased by \$100,000;

and

b) that it be recommended to the Board that the \$100,000 be reallocated to the library system from the "non-academic" or service functions identified in the document of April 16 of the Financial Planning Committee, and following in so far as possible the priorities set out therein.

An amendment was moved and seconded (Andrews/Rodger) that recommendations a) and b) be voted upon separately. The amendment was carried.

An amendment to vote on recommendation b) first (Cameron/ Scheibelhut) was defeated.

Upon vote, recommendation a) was carried.

An amendment to recommendation b) was moved and seconded (Friedenberg/Godfrey) that the word "the" before "non-academic" in line 2 be removed, and that everything after the word "functions" in line 3 be deleted.

The amendment was carried.

Recommendation b) as amended was then carried.

In the course of discussion of possible sources of funding for the additional \$100,000 for library acquisitions, Vice-President Shaw presented a brief report on the projected 1982/83 budget and described the factors responsible for the "more favorable" outlook in the 1982/83 budget position.

The President stated that he would report to Senate on the source of funds to implement recommendation a).

82:36. Reports and Recommendations -- Committees of Senate

B. Senate Library Committee

1. Year-End Report

Mr. Archibald, Chairman of the Senate Library Committee, introduced and reviewed the report, with specific emphasis on long-term funding.

Upon motion (Josenhans/Horrocks) the report was received.

It was moved and seconded (Betts/Horrocks) that

the following resolution from the report be approved.

"Senate strongly endorses and supports increased efforts to include the libraries in the Annual Giving Campaign and any capital funding campaign of the University; and that apart from these endeavours the University administration encourage potential benefactors to endow the libraries."

Mr. Tonks served notice of motion that he would request that the Senate Library Committee increase its membership in order to include representation from all faculties.

The Chairman indicated that the matter would be referred to the Committee on Academic Administration for consideration.

Senate endorse the proposed guidelines applying to research grant overhead, and that, since the Library is a major overhead expenditure, both the Administration and Departments designate a portion of their overhead receipts to support the Library.

The motion was carried.

the Senate constitution be amended to increase the membership of the Physical Planning Committee by one, to facilitate adequate representation.

The motion was carried.

There being no further nominations, the two were declared elected.

Financial Planning Committee

Two nominees are presently members of the committee whose terms expire 1 June 1982 and who have agreed to continue.

Mr. Warwick Kimmins (Biology) was nominated from the floor by Mr. Belzer, seconded by Mr. Maloney and Ms. Stewart.

The Secretary was instructed to contact Mr. Kimmins to determine his willingness to run for the position, and, if he is willing, to conduct a mail ballot for the two vacancies on the committee. Should he not be willing to run, the Chairman indicated that the other two nominees would be declared elected.

Ms. Runte reported that the Committee on Committees would be notifying eligible members of the university community of the activities of Senate committees to obtain an indication of interest in serving on these committees.
