Report of Ad Hoc Committee to Review Terms of Reference of the Senate Discipline Committee

It was moved on behalf of the committee (Darby/McKee)

that Senate adopt the report of the *Ad Hoc* Committee to Review the Terms of Reference of the Senate Discipline Committee.

Mr. Darby explained the background to the ad hoc committee's recommendations.

Ms. Fingard asked if the terms included graduated students and could the penalty include revoking a degree. She was told that this was possible under the proposed rules. It was also explained that faculty could not take appeals to the Appeals committee.

Ms. McIntyre suggested that the appeal be to an ad hoc committee of Senate. This was accepted as a friendly amendment by Mr. Darby on behalf of the committee.

Mr. Kussmaul asked about the application of disciplinary proceedings against students who provide fraudulent information on their application but never register at Dalhousie. Mr. Darby replied that there is a need for the ability to discipline such students. Mr Stuttard suggested revoking the admission of students who have registered as a Dalhousie student using fraudulent documentation.
