Report of the President
The President reported that the University had recently hosted an important Conference on Technology and the Economy, designed to introduce the combined strengths of Dalhousie and DalTech in the field of education and research. The Conference brought together many of the province's business leaders and agency heads with responsibility for economic development at the provincial and federal levels. The approximately 120 individuals in attendance gave positive feedback on what appeared to have been a successful part of our attempts to build both partnerships and an appreciation of the strengths of Dalhousie and its contributions to this community. He trusted this appreciation would result in long-term increased support for the University, through philanthropy, partnerships, and government support for our operating budget. The President distributed copies of a new brochure which had been launched at the Conference. Similar to the brochure detailing Dalhousie's strengths in Ocean Studies,
this initiative set out the impressive range of academic activity in a wide variety off fields, which involved both campuses and many Faculties. He acknowledged the formal process by which Areas of Special Emphasis were to be determined by the University community. However, he believed that, having examined the brochure, few members would have any doubt that this was an Area of Special Emphasis and strength.

With reference to the recent MPHEC hearings on quality assurance, Mr. Bradfield asked how long the University's presentation to those hearings had been in preparation, and whether any Senate Committees or Officers had participated in preparation of the document submitted. Mr. Stuttard explained that the document had been prepared by Mr. Christie's Office, without participation of any Senate Committees. Mr. Bradfield asked whether any Senate Committees would be considering the document, since quality assurance was a function of Senate. Mr.
Stuttard noted that given Mr. Christie's frequent attendance at SAPBC, it might be appropriate for that Committee to review the document. Mr. Traves noted that the document was simply a report or catalogue of the many quality assurance mechanisms and procedures in place at the level of Departments, Faculties, and Senate. It did not propose new efforts or activities in this area; however, he would be happy to submit it to the appropriate Senate Committee.

Mr. Ugursal asked whether the May 8 memorandum from Mr. Mason concerning amalgamation savings and costs was the Report which would be submitted to the government at the end of June, as the Annual Report. Mr. Traves explained that the May 8 memorandum might be apart of the Report; but the Annual Report would be in the nature of progress report on the past year. When that Report was prepared it would be circulated to Senate. Mr. Ugursal wondered whether Senate would play a role in the preparation of that Report. Mr. Traves didn't think it was the custom to consult with Senate on what would largely be a catalogue of what had been done to date. The Report would not include policy statements.
