## 2002:102.

Draft Minutes of Previous Meeting
a) The minutes of the meeting of September 23, 2002 were ADOPTED.
b) Matters Arising:

Mr. Traves commented that in response to material presented at the previous Senate meeting and questions surrounding the source of data for that presentation, he was circulating a document prepared by the Maritime Provinces Higher Education Commission and taken from a recent report on faculty recruitment and retention in the Maritime Provinces. That document provided student-faculty ratios for Maritime Universities. At that previous meeting, data presented was in relation to comparator universities with medical schools and doctoral programs.

## 2002:103.

Chair's Remarks

Mr. El-Hawary reported that at it’s September 16, 2002, meeting, the MPHEC approved the Cooperative Undergraduate Diploma in Disability Management, the Bachelor of Science
(Occupational Therapy), the Master of Health Informatics, and the Graduate Diploma in Prosthodontics with Master of Applied Science (Biomedical Engineering) programs.

As prescribed in the "Guidelines for Centres and Institutes at Dalhousie", annual reports have been received from the inter-Faculties Atlantic Health Promotion Research Centre, the Health Law Institute and the Neuroscience Institute. Dr. Steven Barnes has replaced Ian Meinertzhagen as Director of the Neuroscience Institute.

Mr. El-Hawary also reported on hearing the Minister of Education comment in relation to the issue of the double cohort from Ontario and admission criteria to Nova Scotian universities such that Nova Scotia students should not be denied access because of that external demand. He stated that the Senate Academic Planning and Budget Committee would be examining the criteria under which Dalhousie currently functions, in relation to this issue.

## 2002:104.

Question Period
Mr. El-Hawary observed that some recent messages on the Senate listserv commented on a perceived lack of debate at Senate. He suggested that one small way of encouraging more discussion would be to have questions that might be directed specifically at a particular senator or member of the Administration submitted ahead of time so that if background preparation was needed, it could be done before the question was raised at Senate. Mr. Whyte commented that this might enable senators a better opportunity to represent their various faculties and to gather some input from their faculties to bring to Question Period.

Mr. El-Hawary indicated that members wishing to submit questions in advance could do so through the Senate Office. Members would also be free to follow the existing practice of asking questions during Question Period

Library Acquisitions
Messrs. Louden and Scott had asked that the Senate discuss the University's Libraries' acquisitions and future implications. As Mr. Louden was not present to open the discussion, Mr. El-Hawary invited Mr. Maes to address the issues.

Mr. Maes, using Power Point slides (copies distributed), addressed the major issues currently facing the University in terms of the Library. He indicated that the major problem was, that over the last sixteen years, the Library has been faced with an $8-10 \%$ overall inflationary cost increase on its acquisitions budget for serials. At the same time, the serials budget has not increased enough to sufficiently address these inflationary costs. He discussed the rising costs of information in terms of the added value of purchasing some electronic issues such as Science which may have high costs but also have increased benefits in terms of accessibility. He also spoke of issues related to decision-making in maintaining both electronic and print versions of the same title; the time and effort to negotiate consortium deals that could save money; the practice of publishers passing on to libraries the costs of moving to electronic versus print text to libraries; an emerging consolidation within the publishing industry whereby with fewer choices to customers, a greater monopoly evolves and subsequently publishers can charge higher prices; and finally, "aggregators", that is vendors who serve as distributors between the publisher and customer, with deals that combine several titles (desired or not) for one price. Mr. Maes gave examples of several high-cost serials that could be deemed to be essential to the Library, such as those included in the Web of Science. He described strategies that could be seen to affect the rising costs, for example, moving to electronic publishing where "they deliver, you print", and huge package deals of titles which can be purchased for an increase in fee. He suggested that consortia amongst research groups for example, might develop an alternative that is a less expensive model of publishing. Another option could be further improving document delivery services. Mr. Maes presented short-term options such as continuing cancellation of serials every year, and/or raising library funding and increasing participation in consortial deals. In terms of long-term options, he suggested encouragement and support for new models of scholarly publishing. Mr. Maes then described the consequences of each option. He concluded by suggesting that a fundamental change is needed in the scholarly communications model, for scholars to become more familiar with how publishers operate, to become more knowledgeable regarding the negotiation of copyright issues as presented by publishers for scholarly work; and to support alternative publishing models being developed by research groups and societies. In terms of the University, Mr. Maes suggested developing a plan for the next few years that will enable time to achieve change in the current model operation.

Mr. El-Hawary began the discussion by stating that there is a question of credibility within each discipline that impacts on whether one can choose to publish or not in a particular journal. He indicated that there should likely be a federal initiative, through its science and technology policies, to help address these problems of university libraries. Mr. Maes responded that he is President of the Canadian Association of Research Libraries and that organization has been lobbying government to allow them to participate in conjunction with AUCC, in indirect costs discussions, however, the longer term problem will continue to persist in the meantime.

Mr. Breckenridge stated that the issue has not been part of the discussions amongst the VicePresidents Research group, but he would raise it in future discussions. Mr. Traves commented that the Site-Licensing Agreements have been a start in beginning to address some of the issues. Nevertheless, he re-iterated Mr. Maes' comments that the issue of the model of scholarly publishing and distribution needs to be addressed. Mr. Mitchell commented that efforts should be taken to lobby government to initiate efforts to address the publishing monopolies. Mr. Moore commented on the issue as it affects and can be affected by scholars as individuals and at
an institutional level, for example, in tenure and promotions considerations. Ms. Parpart suggested the discussion served as a "wake up call", and that the issue is a global one in terms of setting standards for what is considered an acceptable standard for a research university. Mr. Whyte questioned the practice of providing electronic access as part of the Library's role versus simply having a place where print journals are provided. Mr. Maes responded by describing issues of equitable accessibility. Ms. Macrae commented that students value the accessibility provided through electronic journals, as well as Novanet access and improved document delivery. Mr Cochrane commented that Universities are the source of information to be published and should have some power over how that information is distributed. Ms. Neves commented that the most frequent question from students is in regard to how to access journals from home to enable their academic work to fit in with other responsibilities such as employment, and hence having electronic journals is an asset from that perspective.

Mr. Maes was thanked for his presentation and participation in the discussion.

Mr. El-Hawary reported that both the Steering Committee and the Senate Academic Priorities and Budget Committee agreed to forward the proposed Health Care of the Elderly Residency Training Program to the Board of Governors for its consideration. Approval by the Senate was not required since no Dalhousie diploma or degree is awarded. However, for funding purposes, approval by the Board and MPHEC was required.

## 2002:111.

Report of the President:

Mr. Traves congratulated all those who were to receive degrees at the upcoming convocation on October 12, 2002. He announced that honorary degrees would be awarded at the morning convocation to Mr. Ian Thompson and Mrs. Donna Thompson in recognition of their commitment and community efforts in relation to Cystic Fibrosis, and in the afternoon convocation, to Mr. Frank McKenna, former Premier of New Brunswick.

Mr. Traves reported on the enrolment data for this academic year as compiled by the Atlantic Association of Universities. He indicated that a complete report would be forthcoming from Vice-President Scully. Mr. Traves presented a few highlights: at Dalhousie, undergraduate
enrolments were up by $8.9 \%$, graduate enrolment was up by $10.5 \%$, and international students enrolment was up by $24.2 \%$. This results in a total of $9.2 \%$ additional students. He noted that Dalhousie students comprise $51 \%$ of university students in Nova Scotia. He also noted that as there was no increase in the provincial operating grant this year, the academic needs of the additional 1048 full-time and 195 part-time students were being addressed with the same provincial grant resources as last year.

Mr. Traves congratulated Professor Brian Hall on being named a finalist for the prestigious 2002 Gerhard Herzberg Canada Gold Medal for Science and Engineering. Another finalist is Dr. Barrie Frost, a Dalhousie PhD graduate, of Queen's University.
