Senate Committee on Academic Administration: Faculty of Engineering - Draft Co-op Regulations

On behalf of the Senate Committee on Academic Administration, Mr. Fraser MOVED:

THAT Senate approve the following amendments to the Faculty of Engineering Co-op regulation Calendar revisions, with implementation effective for all students entering their third year of Engineering in 2012-2013.

The Program is open to students who:

1. Are registered in the Bachelor of Engineering Program;

- 2. Have attained a minimum cumulative grade point average (CGPA) of 2.3 (or equivalent) in the Diploma of Engineering program;
- 3. Have completed all requirements for a Diploma of Engineering or equivalent;
- 4. Are eligible to work in Canada.

To be eligible to participate in a work term students must:

- 1. Successfully complete the on-line Co-op Orientation Workshop;
- 2. Pay the Co-op fees;
- 3. Register for the work term course(s);
- 4. Submit Co-op Work Permit applications if they are international students;
- 5. Receive a passing grade for all previous work terms;
- 6. Maintain a minimum CGPA of 2.3 (C+);
- 7. Have met all the academic pre-requisites for the particular co-op term.
- 8. Submit a signed Co-op Agreement Form.

Students interested in participating in the Co-op Program, should be aware that work terms exist in a variety of public and private settings. To improve the likelihood of a successful job search, students should begin the employment process at least two months prior to the start of the work term. Students will be assisted by the Dalhousie University Engineering Co-op Office, and efforts will be made to find a work placement for each student eligible for the Co-op Program. There are, however, no assurances that each student will receive a Co-op position. Students with high CGPAs, enthusiasm, and professional potential have typically had the greatest success in securing Co-op employment.

Chair of Senate Report

Mr. Fraser expressed condolences on behalf of Senate to the family of Ken Heard who passed away on May 7, 2011. Dr. Heard was a former Senator and faculty member in the Political Science Department. Mr. Fraser also extended condolences to the family of Wallace McCain who passed away on May 13, 2011. Dr. McCain was a dedicated friend of Dalhousie and had received an honorary degree from the University in 2007.

Mr. Fraser reported that the following items were approved by the Senate Academic Priorities and Budget Committee on behalf of Senate: modifications to three programs offered at the Nova Scotia Agricultural College-Bachelor of Science (Agriculture), Major in Integrated Environmental Management; Bachelor of Technology, Major in Applied Science; and Bachelor of Technology, Major in Environmental Landscape Horticulture;

suspension of admission to the PhD (Nursing) and the Bachelor of Arts (Linguistics) programs; and termination of Dalhousie's participation in the inter-university Master of Arts (Gender and Women's Studies) program. Mr. Fraser also reported on the lifting of the probationary status from the undergraduate medical education program. Mr. Fraser reported that the Atlantic Health Promotion Research Centre (AHPRC) recently had been reviewed and In response to a recommendation of that review, a working group had been established to explore more fully the potential synergy between the AHPRC and the proposed Health Policy Research Centre. The working group will examine the possibility of developing a research institute or centre in health promotion and policy.

Mr. Fraser extended thanks to all faculty and staff who took part in the 14 convocations from May 24 – June 1, 2011. He noted that the next Senate meeting is scheduled for September 26 from 4:00pm – 6:00pm and there will be an orientation session for Senators and Senate Standing Committees on September 7 from 12:00pm - 2:00pm in University Hall, Macdonald Building.

Senate Committee on Academic Administration: Student Accommodation Policy - Amendment

Dorothy Pedlar, Director, Student Accessibility Services, and William Hart, Acting Executive Director, Student Academic Success Services, provided background on the proposed amendment to section 8 of the Accommodation Policy for Students.

On behalf of the Senate Committee on Academic Administration, Mr. Fraser MOVED:

THAT Senate approve the proposed amendment to paragraph 8 of the Accommodation Policy for Students [sentence containing the amendment in bold]:

8. Where the request is for academic accommodation, the Student Accommodation Office, in consultation with the class instructor, shall assess the recommendation in light of the factors set out in section 7 above, and the parameters for academic accommodation approved by the Faculty responsible for the delivery of the class, and shall make a decision concerning the accommodation. Where the circumstances are not addressed by the approved parameters, the Student Accommodation Office shall also consult with the Student Accommodation Liaison. The Student Accommodation Office shall inform the student, those who are necessary for the implementation of the decision (such as the course instructor), and the Student Accommodation Liaison of the decision. Decisions concerning accommodation shall be made and communicated within ten working days of receiving the student's request and all relevant supporting documentation. In certain circumstances, additional time may be required to determine the appropriate accommodation plan for the student. A request can be expedited at the request of the student if circumstances warrant. In consultation with the Student Accommodation Liaison, and class instructor as required, the Student Accommodation Office may review accommodation plans from time to time to determine whether any adjustments to the accommodation plan are necessary.

The motion CARRIED.

Mr. Fraser thanked Ms. Pedlar and Mr. Hart for their presentation of the amendment to section 8 of the Accommodation Policy for Students. The revised Accommodation Policy for Students is available on the Senate website.

Senate Steering Committee: Student Ratings of Instruction - Policy and Procedures

Susan Spence Wach, Associate Vice-President, Academic Programs, and Lynn Taylor, Director, Centre for Learning and Teaching, presented the Student Ratings of Instruction – Policy and Procedures. The Student Ratings of Instruction (SRI) Policy was developed as part of a broad strategy for continuous improvement in learning and teaching at Dalhousie. In 2009-2010, the Senate Committee on Learning and Teaching (SCOLT) conducted an extensive literature review and held over 30 consultation meetings involving Faculties, Senate committees, and others, developing a draft policy—similar to policies currently in place at several other Canadian Universities.

On March 22, 2010 Senate adopted the following policy statement on student ratings of instruction:

Student ratings of instruction are part of a broad strategy for continuous improvement in learning and teaching at Dalhousie University. Student ratings of instruction:

- Are to be undertaken in applicable undergraduate and graduate courses;
- Involve a set of common questions as well as additional customizable questions of value to individual instructors, and to academic units;
- Enable student access to summary results based on the common questions;

and that Senate agrees that the remainder of the draft Policy for Student Ratings of Instruction, presented to Senate on March 22, 2010, serve as a working document for further consultation over the next twelve months.

The Policy for Student Ratings of Instruction and the Student Ratings of Instruction (SRI) Procedures for Collecting SRI Data and Reporting SRI Results have been approved by the Senate Committee on Learning and Teaching (May 15, 2011), Senate Steering Committee (May 16, 2011) and Senate Committee on Academic Administration (June 1, 2011). A full discussion followed with a question and answer period. It was noted that it was anticipated that on-line completion of the SRI instrument would be in place by Fall 2012.

The following points on the Student Ratings of Instruction were noted:

- Common questions 1 to 9 in Section A of the SRI instrument (circulated with the meeting package) were intended to reflect, and to communicate to students, the complexity of teaching and learning.
- It was observed that there was ambiguity in items 4.5 to 4.7, and the results of the common questions should be released to students only where the results were from classes with at least 10 responses, and response rates of 40%.
- It was suggested that online courses were not comparable to classes held in person and should be treated differently in the SRI process. It was also suggested that bringing the process online would introduce bias in the responses.
- It was noted that there should be more clarity in what data could be used for tenure and promotion purposes. There was a request for a procedure with which Deans could obtain SRI data from departments. Section A would be made available for the summative nature of its data, while the data in Sections B, C, and D (unsigned comments) were considered formative and thus would not be available for tenure and promotion purposes. This discussion will be explored further in the Fall 2011.

On behalf of the Senate Steering Committee, Mr. Fraser MOVED:

THAT Senate approve the *Policy for Student Ratings of Instruction* and the *Student Ratings of Instruction* (SRI) Procedures for Collecting SRI Data and Reporting SRI Results.

The motion CARRIED.
