#### Minutes

Minutes of the meeting of May 28, 1981, which had been circulated, were approved.

## Committee Reports

Staff Relations Committee

A report of this Committee was circulated at the meeting, and was introduced by Judge Nathan Green. The President commented upon certain appointments deserving of special mention. He also referred to the deaths of three members of the Faculty, Drs. W. A. Tomblin, H. J. MacConnachie, and H. K. Hall.

Building and Grounds Committee

Mr. G. E. C. Brown reported briefly. It is still expected that the rink will be ready for use by the end of February. It is estimated that there will be a cost overrun of \$200,000.00

A firm has been engaged to do a space utilization study. It is intended that there be no construction or major renovations until this study has been completed.

Finance and Budget Committee

Miss Zilpha Linkletter reported for this Committee. The Committee is meeting regularly and trying to deal with the financial problems of the University. Members have the firm conviction that the objective must be for a balanced budget for 1982/83.

#### Academic Matters

The President advised that there was nothing significant to report on this item, except that some information concerning funding has been received from M.P.H.E.C.

It was agreed that the name of the School of Recreation, Physical and Health Education be changed to "The School

of Recreation, and Physical and Health Education".

# Report from the President

The President reported on certain activities of the Association of Universities and Colleges of Canada. A meeting had recently been held with Mr. Axworthy, Minister of Employment and Immigration, and other government officials concerning the funding of post-secondary education. The meeting was less satisfactory than had been hoped.

An agreement has been drawn up for affiliation with the Nova Scotia Rehabilitation Hospital and is now being examined by our solicitors. The Officers of the University were authorized to sign this agreement.

## Current Financial Situation

The President reviewed the present financial situation and outlined steps that are being taken to improve this. He reported that in this process the Board of Governors, the Budget and Finance Committee of the Board and the Financial Planning Committee of the Senate are all involved. In addition, he has written to the Senate inviting Senate participation. He advised that an attempt is being made to avoid a declaration of financial constraint.

Dr. W. E. Jones reported that the Financial Planning Committee of the Senate has prepared a document which includes a number of recommendations. As this had not yet been presented to Senate, it was felt that it would be premature to circulate it to members of the Board. It will go before other Committees of the Senate for discussion on Monday October 26, 1981 and will be discussed at a meeting of Senate to be held on November 2, 1981.

There followed a general discussion on the financial situation in which several of those present participated.
