DALHOUSIE UNIVERSITY School of Dental Hygiene

Entrance requirements for enrolment in the Dalhousie School of Dental Hygiene (Faculty of Dentistry) have been modified.

During the first years after the school was established a student was expected to have credit for seven subjects of junior matriculation.

The Senate of Dalhousie University now has approved addition of a pre-professional year at university level, as a requirement for admission. This requirement will become mandatory for applicants for the class which is to start in the fall of 1964.

The school conducts a two-year course, leading to the Diploma in Dental Hygiene. Available facilities necessitate limiting the number of students in each year. Preference for admission will be given to students who have received credit for classes in English, Chemistry, Psychology and Sociology.
