There was also one special meeting of Library Council held on October 2nd, 2015 to discuss the Self-Study for the Senate Review of the Libraries. Eight staff attended that meeting.

Members of Library Council for 2015-16 included:

The total membership of Council during this period was 51 members due to an overlap prior to a retirement. Quorum for Council is 50% + 1 of the voting members or 26 voting members. Council maintained quorum at all meetings during this period.

Business of Library Council

Council continued to function as a planning and information sharing venue for the Libraries. This year the member 'Community Updates' were moved closer to the top of the agenda, and each member present was encouraged to provide a brief (maximum 2-minute) highlight of their system-wide and library-specific activities and areas of research. The team-based approach for many initiatives and the various functional groups reporting through the AULs were more evident in the highlights discussed this year. Library Council discussions included building renovations and space changes for the Wallace McCain Learning Commons, Kellogg Library Learning Commons in the Collaborative Health Education Building (CHEB), renovations in the Kellogg and Sexton Libraries, BrightSpace implementation, the University's Strategic Initiatives, the website redesign, EAF activities regarding collections allocations, planning for new positions, Strategic Plan implementation updates, preparations for the Senate Review of the Libraries, and budget updates. Council also provided an opportunity for members to deliver presentations on their research, committee work, and items of concern for the libraries.

There were 8 motions passed:

- September 2015 -- To add two positions to Library Council Instructional Systems Manager and Manager of Services, Support and Training
- October 2015 -- To amend the LIPCC terms of reference
- November 2015 -- Gift Policy; and To encourage SMT to not pursue the call for interest for the co-location of LAC
- December 2015 To adopt the revised version of the Senate Election procedures
- January 2016 -- To adopt the final version of the Assessment Priorities document
- March 2016 -- To dissolve the Information Literacy Committee
- April 2016 -- To accept the Health Sciences Limited Term position (job description).
