2.4 <u>Senate Planning and Governance Committee: Academic Amnesty Request for Global Youth Climate Strike - September 15, 2023</u>

THAT Senate approve that all individuals involved in synchronous teaching delivery at Dalhousie University on September 15, 2023 from 11:00 a.m. to 4:00 p.m., allow students who wish to participate in the Global Youth Climate Strike to do so without academic penalty due to their absence, subject to the following:

- 1. Students are to inform their professors at least twenty-four (24) hours in advance (by 11:00 a.m. on September 14, 2023) if they plan on missing an assessment in order to attend the event.
- 2. Make-up assessment(s) will be at the discretion of course instructors, subject to appropriate faculty regulations.
- 3. For the inclusion of students travelling from and to the Truro or Yarmouth campuses, no specific time is provided.

4. 4.1 Introduction of Cheryl Fraser, Chair, Board of Governors

4.2 <u>Introduction of Kim Brooks, President and Vice-Chancellor</u>

Senator Spiteri provided an overview of the background and experience of Senator Kim Brooks, appointed as Dalhousie's 13th President and Vice-Chancellor Chair of the Dalhousie Board of Governors in July.

Senator Harvey read a statement on behalf of Senator Brooks. Senator Brooks' statement noted the importance of Senate and welcomed back all Senators for the new academic year.

The Chair of Senate's Report was included in the Senate meeting package for review. Senator Spiteri informed the meeting that the primary focus of Senate would be working on the

recommendations of the Governance review. Senator Spiteri emphasised that any changes and approvals would undergo the usual approval process.

6. Senate Orientation and Rules of Procedure

Senator Spiteri and J. Hope presented the Senate and Senate standing committee orientation.

The presentation outlined the statutes relating to Dalhousie University; the bicameral governance structure of Dalhousie University; the roles and composition of both the Board of Governors and Senate; Senate jurisdiction, principles, and values; Senator responsibilities; the role of the Senate Officers; the role of the Senate standing committees; the Senate schedule; a typical Senate agenda; and recent Senate Planning and Governance (SPGC), Senate Academic Programs and Research Committee (SAPRC) and Senate Learning and Teaching Committee (SLTC) business.

N. Strowbridge provided an overview of the Senate Brightspace page and how to navigate Brightspace to access current and archived Senate meeting packages and information.

7. Question Period for Orientation

Responding to a query from a Senator regarding the Third Century Promise strategy, Senator Harvey assured Senators that Dalhousie remained committed to the strategy.

In response to a question regarding Senate's role in the Okanagan Charter, Senator Harvey clarified that Senate's main role was academic quality assurance. Senator Harvey however noted the advantage of Senate receiving periodic updates regarding the Okanagan Charter.
