Where does the deficit come from?

A significant portion of the deficit is salary commitments (administrative leaves) but there are also some unexpected costs. The Dean is working on the budget submissions with Hershan Fernando to work towards a balanced budget over time. It is hoped we can make better decisions when there are staffing departures and keep on top of the budget so the libraries don't continue to be in a deficit.

Action: At a future Library Council meeting, the Dean will prepare a presentation with data to show how our staffing looks now in terms of the different categories, how it compares to our Canadian Association of Research Libraries (CARL) piers and how our overall staffing situation compares within the university.

Do we have a plan for funding long-term laptop lending? Has this been decided?

We have consulted with students who are and have used the laptop lending program to find out why they have been using the program. The results determined there is a strong need for the service. The libraries had this service for some time but since the pandemic, the need is greater. It was noted, the equipment needs to be replaced so there is a need to find funding.

Is there a strategic plan for budget management, moving forward? For example, sometimes that includes engagement and consultation sessions with all employees.

Our budget is 80-90 percent committed to salaries. The strategic plan for the budget is managing around a small amount for professional development and some of discretionary things we do for Facilities Management, furniture etc. The strategy comes in with the engagement with the university, while we are provisioned in the middle of the U15 in terms of the number of students per Librarian. On top of that, we are having cross discipline roles which is responding to real needs. At Dalhousie and many of our piers there are double the number of Faculties and disciplines compared to universities like Queens. Between the priorities that are being presented, we have to decide where the money is going. We have opportunities through the Integrated Planning and Academic Quality Assurance to make clear messaging about what the impact of increased enrollment or new or changing programs and courses. All this work is important but we need to be clear about what the impact of changes will be. We need to say the small incremental changes have a big impact cumulatively. We need to build a good understanding with the Administration of the impact and role of the libraries and what the risks are to any reduction in services. We need to specify how we will balance our budget (over a 3 year period) with cuts (where most of the budget goes to staffing). We have two kinds of messages to the university: "what we can and should be doing" and "what the impact will be when funding the libraries compared to what it will be if the libraries are not funded (the impact on services will be great and the expectations will not be met for our students and faculty).

Is there an opportunity to share services to help with some of the expenses.

There are already some services that are shared across the libraries eg. Document Delivery, printing etc.

Putting money on DalCard

This is only done at the McRae Library because students and staff have nowhere else to have this service done. Charging for services is a whole other ballgame within the university. Would not want to create an internal economy because the costs outweigh the benefits.

The Senate Report mentioned a Library presentation on diversity – can we have access to that? A similar presentation will be done by Michael and Samantha at the All Staff meeting next week.

Can someone remind us if Springshare has rolled out any other elements other than their room bookings? Through LibCal we initially used it for events, but LibCal appointments was a big part of it and then a privacy impact assessment had to be completed which delayed the implementation so some staff moved to MS Bookings. Within LibCal, there are spaces, calendars, appointments and rental of technical pieces. The Dal Libraries also recently implemented an FAQ using LibAnswers.



Monthly highlights (1-5 key events, meetings, etc.):

Oct 16 – Novanet Board of Directors and Succession Planning meetings were held in-person at the Novanet offices in Bedford. A joint CAAL/Novanet Task Force is being struck to explore possibilities for a shared future for the two groups.

Oct 17 – Attended my first OCLC Canada Advisory Council meeting. The meeting included an introduction to the OCLC Research Library Partnership (https://www.oclc.org/research/partnership.html) and a roundtable on trends and emerging priorities in the Canadian library landscape.

Oct 18 – Participated in the 18th annual Mawio-mi. Catherine Martin led a circle to welcome the new table in the Ko'jua Okuam and introduce its makers, Jim and Mary Walsh. Thanks to Elaine and Samantha (and Janice before she retired) for their efforts to bring the table to Dal and to organize this special part of Mario-mi.

Oct 19 – Chaired a Copyright Advisory Meeting which included a review of the Copyright Office annual report prepared by Jaclyn Chambers Page and Scott MacPherson. While I chair these meetings, I depend on the knowledge and expertise of Jaclyn and Scott to answer the challenging questions. This meeting included excellent engagement with committee members who brought forward helpful questions related to controlled digital lending and how we display usage rights information to our users.

Oct 23 – Dal Libraries was on the agenda for the Senate Meeting. Samantha and Elaine prepared a very well received presentation on Dal Libraries Indigenous initiatives, updating Senate on library activities since the opening of the Ko'jua Okuom. Samantha and I will do a version of this presentation at the upcoming all-staff meeting on November 14.

Oct 23 – I led an agenda item on the Integrated Software Governance Committee meeting describing the work of a newly formed task force to develop a data governance rubric/matrix for the university and to call for volunteers to join the group.

Oct 25 – Deans Council was held in the MacRae Library in Truro prior to a farewell gathering for David Gray. It was nice to see some of our Dal Libraries people in person and to have the opportunity to wish David the best in his new role in at the new University of Niagara Falls in Ontario

Oct 27 – The Council of Atlantic Academic Libraries (CAAL) Fall 2023 Board meeting was held in the Mona Campbell Building on our Studley Campus.

Oct 30 – The Senior Leadership Team attended a meeting with the Dalhousie Integrated Planning Committee to review our submission, provide us with an opportunity to highlight areas of note, and respond to questions about our budget and priorities. We were a larger group than they expected, but I was happy to share the experience with our senior team and felt confident being accompanied by people I knew could respond knowledgeably and compellingly about all aspects of our organization. President Kim Brooks joined our meeting and took considerable interest in both our operational details and vision for the role libraries can play in the academy.

The event was facilitated by Catherine Martin, and Chief Bob Gloade and Grand Chief Norman Sylliboy accepted the apology and provided formal remarks.

Oct 19 – Dalhousie co-hosted the Universities Studying Slavery Conference (https://ussconference.ca) and I am grateful to have been invited to attend the opening keynote, given by his Excellency John Mahama, former President of Ghana. Highlights for November

Associate Dean, Library Services:

Access Services -

- Access Services in the Killam Library has now moved back to the KLSP on the main floor of the Killam as the retrofit project moves along to other areas.
- Sexton Library, under the leadership of Gina Coates, will be hosting, Avery Flinn, a Grade 12 high school Cooperative Education (COOP) student to could provide them with an unpaid community-based learning experience.
 - Halifax West High School offers a unique program that provides the students with a work placement experience designed to improve their communication, personal management and teamwork skills.
 - Students must first complete a 25-hour career research and readiness "in class" component, and then they are placed into the trust of a work host in which they have to complete 80 hours of volunteer work within that discipline or industry. The students are WHMIS, and Occupational Health & Safety and First Aid certified prior to placement.
 - Gina and I met with Avery and Andrew Gavas, their Co-operative Education Co-Ordinator, on October 24th and Avery started their work placement on November 3rd.
- Amanda Sparks is the incoming Chair of the Novanet Access Services Group. This is a two-year term. Jan Pelley is the Co-Chair and note-taker for a one-year term.
- Nellie Clyke, Kyoo Lee, Leah Unicomb, Joe Wickens and Johnelle Sciocchetti attended the Access Conference (Oct. 23 24).

Assessment - The library data inventory continues and I will be prompting the remaining units (aside from ATS) to aim for completion by the end of December. Consultations for library data reporting also continue. Attended the Canadian Library Assessment Workshop at Western and will be distributing slides and notes to those who expressed interest and to appropriate ADs. Taught a Library Assessment INFO 5570 class with an overview of assessment and its role within management, including a Killam space observation and project planning activities. If you feel you don't have a full picture of library assessment, I'm happy to conduct a session tailor-made for you or your area unit. Last but not least, the Office of the Dean has earmarked funds for a Winter 2024 Libraries Survey and has chosen Insync. There is currently a possibility of a CARL Insync Survey Consortium and we are awaiting confirmation. (L. Bedwell)

Copyright - the Government of Canada has launched a <u>consultation request</u> on the implications of generative Al for copyright. Universities Canada and the Canadian Federation of Library Associations (CFLA) are currently working on submissions; we are currently considering whether to submit a separate response from our institution. The Copyright Advisory Committee (CAC) met on October 19 and the Copyright Office's <u>Annual Report</u>

was delivered. Also, as of Friday afternoon, the ABC Copyright Call for Proposals is out! (J. Chambers Page)

Data & GIS Services – The 2023 DLI National Training will be held online from 2 pm to 5 pm (Atlantic Time) on November 20 to November 22. Registration is free and you can register for as many or as few sessions as you want. This year's content includes a lecture on finding EDI data in Canada and internationally, as well as a lecture about best practices for sharing gender and sexual diversity data. Julie will be contributing a lecture about Indigeneity as covered in the 2021 Canadian Census, as well as two pre-recorded lightning talks: one about data literacy and one about Excel's flash fill feature. Indigenous Services – On Wednesday, October 18th we welcomed the new table with a blessing in the Ko'jua Okuom. The table was crafted by Jim and Cheryl Walsh. The first part of Michelle MacDonald's Beaded Poppy workshop was held on Thursday, November 2nd and was well attended.

Killam Library:

- Reference & Research Assistance staff of the Killam Library returned to scheduled, in-person Reference shifts on October 30th. As it was pre-COVID, those providing the reference service have the option to work the shift in their office space or sit at the KLSP during their shift.
- We've hosted a number of groups of International Baccalaureate students from area high schools in the Killam Library so far this year, including groups from Cole Harbour, Citadel and Woodlawn. Lindsay is also meeting with a small group of 9 students this week from Charles P Allen High School, with the potential of a much larger group from that school later in the month. We've had approximately 100 IB students visit the Killam Library in October. Many thanks to Lindsay and Samantha for providing the tours, as well as to Amanda Sparks and the Access Services staff for their working registering all the students.

MacRae Library:

- Jaclyn and Jolene created a <u>Walktober Bible Hill Ghost Walk</u> as our contribution to Walktober. Thank you to them both for the work (and spirit) that went into planning this fun event!
- Along with Michael, I attended the Farewell Celebration for Dr. Gray on October 25th. It was a lovely tribute to his many accomplishments as Dean of the Faculty and Campus Principal. Dr. Gefu Wang-Pruski has been appointed Acting Dean and Campus Principal for one year, effective October 30th.
- Erin M., Jaclyn, Leah, Erin W. and I have been discussing the distribution of the USD reconciliation funds for the MacRae. With the trend to purchase more ebooks, we're seeing a more multidisciplinary approach to how we allocate the funds. We're also discussing the potential impact on collection development with other faculties beginning to offer a "Truro Start" for their programs. Highlights:

- Dalhousie Libraries is hosting *Drag Storytime with Rouge Fatale* on Friday, November 24, from 2:30-4:30 pm in the MacMechan auditorium at the Killam Library. Drag Storytimes are a regular part of programming in many public libraries, but less so in an academic library setting. With the recent protests and counter-protests in Halifax and across the country regarding the rights of trans youth, we feel it is timely and critical to support the well-being of our 2SLGBTQIA+ communities and to create supportive, diverse, and healthy spaces for exploration and learning. As an academic library, we want to foster dialogue that is informed, open, and respectful, and that draws on expertise of Dal's faculty and research community. This event is open to faculty, staff, and students and will feature a Drag Storytime reading followed by a discussion panel with experts from our Dal community, including Rick Ezekiel (moderator), Matt Numer, Roberta Barker, Stephanie Kapusta, and Jason Spurrell (Rouge Fatale). We want to enable discussion around timely themes and topics and create a safe place to do so. The event page is live, and we will begin promotion in earnest in the coming weeks. You can register now to attend.
- We held *Scary Stories at Sherriff Hall* on Monday, October 30 at 7 p.m. in the Victorian Lounge. This event was presented in partnership with the Writers' Federation of Nova Scotia and featured three local storytellers: Dan Conlin, Steve Vernon, and Cindy Campbell-Stone. The storytellers came dressed in costume and were engaging and funny. We had capacity for 30 participants, and we had only 3 empty seats. Thanks as always to Lindsay McNiff who supports our literary events and for doing the land acknowledgement at the event.
- You may notice the Dal Libraries website has a new background photo and some new photos on the homepage for Library Services and Ask Us. While the redevelopment of the website is still a ways off, we want to align our look with the new Dal brand and provide some refreshes that will reflect that the site is updated and not static. As always, if there is information you are responsible for that is out of date, please email me to chat about how it can be revised to be accurate.
- Dal Libraries is creating an implementation plan for officially adopting Teams as a collaboration tool and SharePoint
 as a file repository to replace the NAS (O drive). A working group that includes myself, the Dean, University Records
 Manager, and a representative from ATS have met to discuss the process for how we undertake this change.
 Employees can look forward to hearing more about this project and providing some direct input during our inperson all staff meeting on November 14.

Academic Technology Services Library Council Report – November 2023 Marc Comeau – Director, Academic Technology Services

- I spent some time meeting with our peers at Queens to discuss their usage of Springshare to book their study rooms. They've had a very positive experience doing that and it's something we're going to be investigating for Dalhousie.
- We worked with some others to help produce some background information to help to support a possible proposal for CONSUP.
- I attended the Access conference which was in Halifax this year. There were many great talks as usual with several of them looking at machine learning from various perspectives within libraries, bringing some debate to the floor over the issues. I expect there to be post-conference follow-up amongst the libraries based on the discussion.
- We have firmed up our plans to replace Ouriginal our plagiarism detection system (text matching software). We are finalizing details with the vendor on the Privacy Impact Assessment and Contract. We've posted a notice in Brightspace with some additional information for faculty.
- I participated in the Integrated Budget Planning Meeting with the senior administration along with fellow SLT members.
- MedIT is leading a collaborative effort with ATS, ITS, Facilities, and the Registrar's Office to work through policy and
 procedure issues around using Teams Rooms systems in rooms that are booked through Infosilem. We're working
 closely with them on this as they have the first use-case, but we expect to have some in Common Pool Classroom
 spaces in the future.

Special projects: Seven Sacred Teachings (Lorne Julien.) Murals purchased and on display at Killam. Also approached by Tayla Paul, artist, for "Peaked Cap Project," a sculpture to be installed near Killam. It will include a bench for contemplation. Using art to contribute to reconciliation.

Art installation in collaboration with local high school, red dress, MMIWG.

Initiatives to decolonize classification and terminology. Working with Novanet and NIKLA. Adding more respectful terminology to describe items in catalogue.
