DALHOUSIE UNIVERSITY

The Future

The university is expected to show continued growth. In recent years the rate of increase in student population has been more than 10 per cent. If this pace continues it will bring enrolment over the 5,000 mark by the end of the sixties.

During that period the Faculty of Graduate Studies is expected to grow to at least 700 students, which was about the total enrolment of the university in 1945.

Such a development requires considerable extension of physical plant and staff. A new medical building, costing \$7,000,000 is expected to be started in the near future.

Other plans call for extension of residences, a new law school, additional wings to the arts and administration building and an auditorium to seat 1,500 which will double as a concert hall. Work is now in progress on an extension to the chemistry building.
