PREPARE FOR DISCUSSION

Use the assigned readings to prepare for seminar style discussion that addresses questions such as:

- 1. How do professional codes of ethics relate to programming and outreach activities?
- 2. What portion of the Society of American Archivists (SAA) Code of Ethics does Freeman and Riter address in their case study on online exhibitions at Loyola University Chicago? How does the case study address these ethical concerns?
- 3. Are there other voices that the "Activist Mundelein" exhibit team should have considered?
- 4. How can archivists avoid assumptions when curating exhibits? Is there a risk in providing too much information about all of the "diverse perspectives" on a given topic?
- 5. What are the "conflicting" roles of special collections departments?
